**NOTICE AND TAKE-DOWN LETTER – ARTICLE 14, E-COMMERCE DIRECTIVE  
(2000/31/EC)**

We act for the abovenamed client Andrew Woodward. We would be grateful if you would note our instruction, provide confirmation of receipt of this correspondence and direct all further communication in relation to the matters raised below to the writer at our Manchester Office in the United Kingdom.

Our client has discovered that the following statements (made by a woman who is stalking him):

***Lancashire Police Officer Andy Woodward Dismissed, 4 November 2016***

- That our client *“caused the collapse of a criminal trial costing the tax payer thousands of pounds due to his conduct in court when he was a serving Police officer”*

***Andy Woodward accused of rape, victim speaks out, 22 November 2016***

- *Ex Footballer, Andy Woodard was ‘sacked’ on 4th November 2016 from Lancashire Police for a rape allegation, (now further assault allegations and text messages suggesting inappropriate comments to a 14 year old girl)*

- *What seems to have been omitted from his 'suspiciously timed' recent mainstream news interviews, is that he had, only one week before, been **dismissed with immediate effect** from Lancashire Police for an allegation of Rape!*
- *Further information has come to light about Andy Woodward assaulting at least 4 other women.*
- *Not one main steam media outlet has mentioned that Andy Woodward was himself a reported rapist.*
- *It is disgusting how a dismissed & disgraced Lancashire Police Officer can get so much airtime, simply because he is an ex Professional Footballer with a rape allegation against him... what about his poor alleged rape victim who seems to be brushed aside and has to watch with distress seeing his face on every news report and TV show!*
- *The following is a statement from Andy Woodward's victim, who at this time has chosen to remain anonymous.*

*"I met Andy Woodward in 2014 when he was allocated to my family by the police as a family liaison officer.*

*Between January and June of 2015, Andy told me about his abuse at the hands of Bennell and used this to emotionally manipulate me. His sexual touching whilst on duty escalated to him raping me at his home address.*

*When I said I was going to speak to someone, he threatened to kill himself. I was left feeling completely responsible for his welfare and was terrified he would end his life.*

*This man destroyed my life. I had to close my business as I was unable to function on a day to day basis. I was left having panic attacks and nightmares.*

*While I still empathise with what he has been through, he was dismissed from the police force for gross misconduct. What he did to me should not be overlooked and as he acted in a practised manner, I'm absolutely certain there are other victims out there.*

*He's never once acknowledged he has done wrong or shown any remorse. The Police misconduct panel acknowledged that he showed no remorse for his actions"*

### **Andy Woodward Assault allegation now public, 25 November 2016**

- *An Andy Woodward **assault allegation** ([read here](#)) has now been made by another victim.*
- *have already spoken with an 'alleged' **rape victim** who has come forward and have seen some damning evidence! Her case was oddly dropped by the CPS. Was this due to him being a serving Police Officer at the time? I understand Police have seen this evidence, so, why the hell was he not charged!*
- *I have been privy to **further evidence** ([now released](#)) that he has also assaulted a number of women, I have seen this evidence from **another of his victims**.*
- *This victim mentioned that Woodward has assaulted at least **4 other women** and is aware of their identities.*
- *I have also seen a witness comment about an inappropriate sexual comment made by Andy Woodward to a 14 year old girl!*
- *He also made sickening threats to this victim to silence her, including threats of suicide, threats of harm to others and fabricating malicious rumours about her to affect her own children.*
- *It appears then that Andy Woodward has been reported to Police for rape & assault of multiple victims, yet nothing is in the press about this and no charges have been against him. **WHY?***

### **Andy Woodward Victims text messages emerge, 26 November 2016**

- A victim of Andy Woodward's has divulged **worrying text messages** that were sent to her, (around March this year) from Andy Woodward's current partner, **Zelda Worthington**.
- Some of the texts show Andy Woodward's partner, Zelda Worthington, telling 'Amanda' how she feared Woodward, how he threatened to spread malicious rumours to discredit her, when she seemed worried about was her children. She explained how drunken Andy Woodward made inappropriate sexual comments to her 14 year old daughter. Also revealed is Woodward's version (in Zelda's words), an alleged rape against 'Amanda'.
- Confirmation from Zelda Worthington that Andy Woodward has allegedly touched up (that is, **sexually assaulted**) 4 other girls, in a 9 month period AFTER he was accused of rape.
- Allegations of drink driving. Andy Woodward was a serving Police officer at the time.
- Zelda Worthington confirms that Andy Woodward alleged to have lied to get into the Police saying he lied on all of the forms.
- Zelda Worthington alleging that Andy Woodward was driving under the influence of alcohol.
- In this messages, from Zelda Worthington states that she caught Woodward in a sexual act with another woman. Woodward was alleged to have threatened suicide as well as saying he could not remember the incident.
- Another text from Zelda to 'Amanda' telling her that Andy Woodward had threatened her that he will tell her ex husband that she is a drug user and alcoholic.
- Woodward got thrills from **touching up Girls**.
- Zelda tell 'Amanda' that she knows the identities of the girls Andy Woodward 'allegedly' inappropriately touched.
- Zelda makes a sickening comment that Andy Woodward made an inappropriate sexual comment to a 14 year old girl (her daughter), telling the youngster when he was drunk that he got a 'hard on' in a hair dressers.
- Zelda tells 'Amanda' how Andy Woodward threatened Zelda with malicious rumours if she told anyone of her assaults. Also allegations that Andy Woodward take drugs.
- Zelda tells Amanda that she thinks Woodward drugged her. Amanda believes Woodward did the same to her.
- Zelda tells Amanda how Andy Woodward sexually assaulted her while she slept.

### **Evidence of Andy Woodward Rape Investigation, 28 November 2016**

- Andy Woodward may well have had a troubled past, but this **does not give him the right to do the same to others**. He has appeared on many TV programs crying saying victims need to be heard, yet, not one mention of the evidence presented here, his own victim not getting heard!
- It is important to note, Andy Woodward was arrested for this offence however no charges were brought. This does not mean the alleged rape did not occur as a few trolls have stated, there are many reason why charges may not be brought including a poor investigation (this site is about just that). It could also be swayed by the fact Woodward was a serving Detective with Lancashire Police with a known history and that would raise a few questions. Lancashire Police are currently under investigation for many other things, please review all articles on this site.

### **Andy Woodward – the FULL Story, 29 November 2016**

- *During a drunken exchange of WhatsApp messages between Andy and 'Amanda', Andy invited 'Amanda' to his home for a drink. His wife and children were home. When Amanda arrived, she reported that she was 'raped' while his wife and children slept upstairs.*
- *After months of mental torture and manipulation, Amanda found the courage to speak to the Police and report the incident of rape.*

**Andy Woodward, why do I even care? 2 December 2016**

- *I have been shown evidence by a friend, that has been raped, raped by a serving Lancashire Police Officer, that was sacked as a result of the 'complaint' of the rape allegation she made, no criminal charges were brought.*

**Andy Woodward resigns from Offside Trust board of Directors, 2 February 2017**

- *After only 1 month on the board of directors of the Offside Trust, disgraced ex police officer and ex professional footballer Andy Woodward has resigned without a single public appearance. This is believed to be due to the 'allegations' of him raping a girl and sexually assaulting others. Another victim has come forward.*
- *Andy Woodward then formed a charity, the Offside Trust of which he became a director. Was this all just a smokescreen to take the limelight off his own criminal past!*

(Offending Webpages).

For the sake of this and future correspondence which may be sent to you and your ultimate customer having control of the Offending Webpage, the Offending Statements and their

publication via your services would form the basis for our client pursuing any further litigation and relief from the Court in relation to their content, notably the allegations contained therein.

The Offending Statements are untrue and are likely (to the extent that it can be claimed that they have not already done so) to damage our client's valuable and hard-won reputation. Their natural and ordinary meaning would be the subject of any further litigation, and without particularising each allegation and our client's response for the sake of brevity, our initial position is that the Offending Statements bear the following meanings:

- That our client has committed rape and various sexual assaults;
- That our client made sexually inappropriate comments to a 14 year old girl;
- That our client caused the collapse of a criminal trial;
- That our client has a criminal past;
- That our client has lied to the police; and
- That our client takes drugs and is a drink driver.

The Offending Statements are clearly calculated to have a detrimental effect and cause serious damage to our client's reputation.

The Offending Statements are, therefore, defamatory and as such we have advised our client that they are, dependent upon your response to this letter, in a position to take action to vindicate the damage done to its reputation by the Offending Statements by issuing Court proceedings in the appropriate jurisdiction against any party involved in the "publication" (i.e. circulation, broadcast and dissemination) of the allegations contained therein, which would ultimately include your business in the event that you do not remove access to the Offending Webpages as requested within this letter.

The Offending Statements are also in breach of your own Acceptable Use Policy.

The Offending Webpages are hosted by you. As such, our client hereby gives you actual knowledge of the above defamation of our client within the meaning of Article 14(1)(a) of the E-Commerce Directive (2000/31/EC), and requests that you act expeditiously to remove or disable access to the Offending Webpages.

If our client receives confirmation within 7 days of the date of this letter that you have removed or disabled access to the Offending Webpages, our client will take no further action against you in respect of this matter. If this confirmation is not received, our client reserves the right to issue proceedings against you seeking relief for defamation. If proceedings become necessary (which may be issued and served without further notice to you), the remedies that may be available to our client include an injunction restraining further publication of the Offending Statements pending trial, damages, legal costs and interest.

In the meantime, our client reserves all its rights in this matter.

This is a complex area of law and we strongly recommend that you seek independent legal advice immediately.

We look forward to hearing from you by 5.00pm (GMT) on Thursday 30 March 2017.
